- should you fail to commence building within 60 days from the date client's application has been approved and the site handed over to you to commence building; and or
- should the Bank in its exclusive opinion finds that your work is of poor and or of substandard nature; and or
- (3) Should you refuse to carry out any instruction from the Bank to rectify any problem or defect in the building works. You also acknowledge that rectification of defects caused by your malperformance shall be for your account and shall be retained or paid out of

any monies that may be due to you by the customer or the Bank. A quantity surveyors certificate indicating all defects and the quantum of funds needed to rectify same shall be conclusive proof of your liability.

(4) This approval is valid for 12 months and is to be renewed on an annual basis. To enable the bank to review this agreement. Please provide us with your latest audited annual financial and 6 month bank statements of the business.

You further acknowledge that:

- (1) the Bank will not be held liable to you for having terminated the contract for reasons stated above; and
- (2) this letter constitutes a contract between you and the Bank only in as far as your performance is concerned and will only to this extent override any contract you may enter with any customer financed by the Bank;
- (3) The Bank withholds the right to do business and remove you from the panel for any reason.
